By visiting and signing up on this website you accept our terms and conditions of service.

### **1. INTRODUCTION**

[EYAMO STORE](#) is a collaborative buying and fractioned payments digital solution/platform accessible via a website application. We allow you to make group purchase via sequential and progressive payments, hence collecting savings in form of instalments towards acquisition of particular items within a pre-set duration of time or minimum amount of money. However the method used by [EYAMO STORE](#) is that of **NON ROTATIVE SAVINGS COLLECTION** which means the default of one or more particular members of the formed crowd/group/bulk buying group doesn't in any way affect the rest of the crowd supposedly of good faith, hence the advantages of the service stay unchanged given all the conditions are respected.

Additionally, regarding our strategy of acquisition that take advantage of Social networks of users to form financing group for a specific item according to financial or socio economical similarities, our users are allowed to share items or products links from [EYAMO STORE](#) to family, friends or relative to form financing group and as such may earn 2.5% fixed term % bonus on their then affiliate's acquisition via a cashback reward system.

Users are charged a % malus which is equivalent to our commission reward or our reward margin on the " to-be-purchased" item subject of the crowd buying financing circle, in case they try breaking a financing group's plan. Breaking a Financing group's plan means stopping to pay as pre-determined by the financing plan and or trying to withdraw your savings under a product when you haven't reach the duration of time or final target amount set before hand when creating or joining the financing crowd buying group.

1. We don't use or invest our customers' savings. We securely store them in the business MOMO and OM accounts offered to us by our payments aggregator partner DOHONE S.A until it's time to acquire the items purchased by our customers.
2. The bonus we offer on our customer's savings is a part of the commission fees some of our partners wholesalers/Whole supplier pay to us as reward or part of the money [EYAMO STORE](#) earned per sold item
3. Since we don't invest our customers' savings, if we are no longer able to deliver our value proposition, we would simply refund every customer's savings back.

### **1.1. Purpose**

We offer the possibility to group purchase or crowd buying as users might access the online store and gather additional users to buy a particular item displayed on the platform via sharing the item's link to his relatives on his/her Social networks accounts, Also the acquisition of the item of interest is made through progressive instalments paid to get possession of this particular product which is the goal of a particular financing or crowd buying group.

As our Clients/users, we will progressively lock your savings so you can make the acquisition of the item/product of your interest hence making a better financial decisions at no hidden cost, FREE. By using our website and mobile applications, you enter into a series of legally binding agreements. You also agree to our Privacy Policy which covers how we collect, use, share and store your personal information.

### **Other Information we collect**

#### **Information You Provide to Us**

#### **Information We Collect Automatically from our Services**

When you access or use our Services, we automatically collect information about you as follows:
